RE: Nuclear Densometer Agreement

Dear Greg:

This letter serves as a formal agreement between Missoula County (the County) and DJ&A, P.C. (DJ&A) whereby DJ&A will allow certain authorized employees of the County to use its nuclear densometers for performing compaction tests on the Missoula to Lolo Trail Project (the Project).

DJ&A agrees to:

- Provide at least one gauge for County employees to use;
- Provide County employees with a copy of DJ&A's Radiation Safety Program (attached to this agreement);
- Train County employees in the safe operation, storage and transportation of gauges in accordance with NRC regulations, DOT regulations and DJ&A's Radiation Safety Program;
- Provide dosimetry badges for on-going radiation exposure monitoring;
- Assist the County in providing safe and secure storage for the gauge(s) at the job site storage facility during week days;
- Audit County employees in the field a minimum of once per month while the gauge is in use;
- Provide any maintenance or repair of gauge(s);
- Provide the County with on-going support with any issues that arise during gauge use, transportation or storage.

Missoula County agrees to:

- Provide County employees with basic gauge safety and certification training as directed by DJ&A;
- Operate, store, secure and transport gauges in accordance with NRC regulations, DOT regulations and DJ&A's Radiation Safety Program;

- Allow DJ&A unrestricted access to any job site where the gauge is in use;
- Check out the gauge(s) from DJ&A's storage facility at the beginning of the work week. Document check-out on the log sheet located in the storage facility with the date, time, operator's name and location the gauge will be used;
- Return the gauge(s) to DJ&A's storage facility at the end of the work week. Document check-in on the log sheet located in the storage facility with the date, time and operator's name;
- Wear dosimetry badges while transporting and using the gauge(s) and return dosimetry badges to DJ&A when asked;
- Only allow employees authorized by DJ&A to handle, operate or transport gauges;
- Contact DJ&A immediately if any problems are encountered during gauge use, transportation or storage;
- Compensate DJ&A according to rates defined in the professional services agreement dated 4/16/15.

By signing below, both parties acknowledge and agree to the aforementioned statements.




