



1. Section F.6 "Period of Performance" is deleted in its entirety and replaced with the following:

"The ordering period for this contract ends on May 31, 2017, five years from the contract's award date. Any orders issued during this period shall be completed within the time specified in the order unless otherwise specified herein. (See 52.216-18 Ordering)."

2. Paragraph d) of Section I.4 "52.216-22 Indefinite Quantity (OCT 1995)" is deleted in its entirety and replaced with the following:

"Any order issued during the effective period of this contract and not completed within that period shall be completed by the Contractor within the time specified in the order. The contract shall govern the Contractor's and Government's rights and obligations with respect to that order to the same extent as if the order were completed during the contract's effective period; provided that the Contractor shall not be required to make any deliveries under this contract after November 30, 2017, six (6) months from the last date of the contract's effective date."
