The purpose of this modification is to obligate incremental funds in the amount of \$105,869.08, thereby increasing the total obligated amount from \$457,920.00 to \$563,789.08.

Accordingly, paragraph (c) under section A.1, CONSIDERATION AND OBLIGATION--COST PLUS FIXD FEE (JUN 1988) ALTERNATE I (JUN 1991), is also deleted in its entirety and replaced with the following:

"(c) The amount currently obligated by the Government with respect to this task order is \$563,789.08, of which the sum of \$522,026.93 represents the estimated reimbursable costs, and of which \$41,762.15 represents the fixed fee."
