The facility was taken over by Munson Healthcare in Dec 2015, but a change-of-control was never completed by the licensee. CN590022 was opened to terminate the Charlevoix license and combine it with Munson Medical Center (L/n 21-08317-01; CN590020), so a change-of-control needed to be documented before that transfer could take place. Upon review, Patty Pelke, MLB Chief, agreed that this action could be voided and combined with CN590022 (see attached email b/t me and P. Pelke).**
