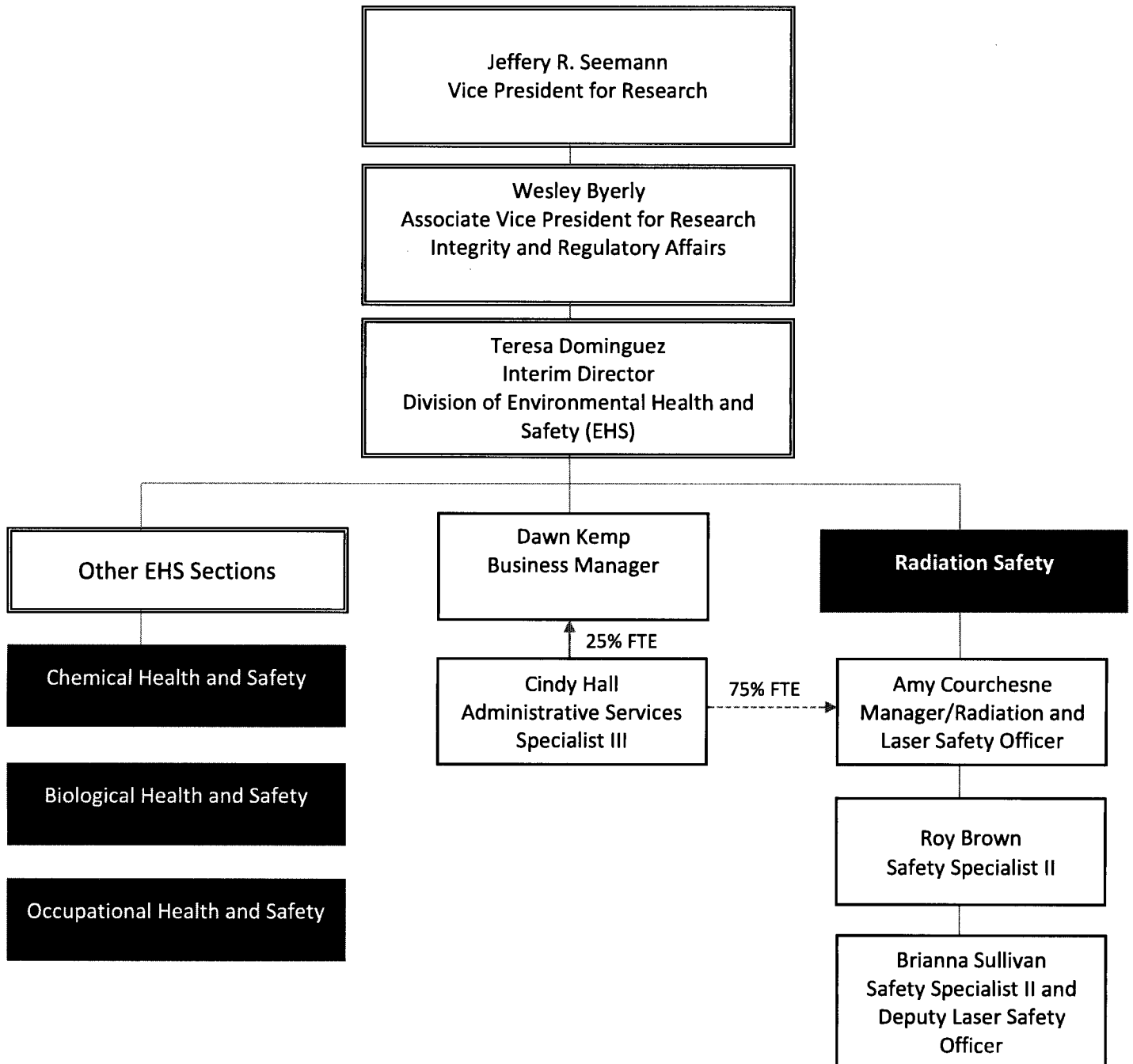

Item 7 – Individuals Responsible for Radiation Safety Program

Executive Management

The table of organization on Attachment 7.1 indicates the administrative structure and control over the safety program. The Radiation Safety Committee (RSC) reports to upper management through the Associate Vice President for Research (AVPR) or designee. The AVPR's authority for enforcement is through the Director of Environmental Health and Safety (EHS) to the Radiation Safety Manager, who serves as Radiation Safety Officer (RSO). Two full-time Specialists report to the Radiation Safety Manager and one part-time Administrative person who reports to the Business Manager assists with the program.
