ACTIVITY CODE NUMBER L34363)

Dear Mr. Thyne:

By letter dated March 21, 2016 (Agencywide Document Access and Management System [ADAMS] Accession No. ML16085A134), in accordance with the requirements of Title 10 of the *Code of Federal Regulations* (10 CFR) 95.19(a), Louisiana Energy Services (LES), LLC dba URENCO USA (UUSA) requested review and approval of Revision (3) to UUSA Classified Plant Management Information System Security Plan (UUSA-CPM-ISSP).

As authorizing official for Louisiana Energy Services' (LES) classified computer networks, the U.S. Department of Energy (DOE) Nuclear Energy Oak Ridge Site Office (NE-ORSO) has reviewed Revision 3 to the ISSP. Based upon NE-ORSO's review, DOE has informed the NRC (Accession No. ML16116A421) that you are authorized, subject to the following stipulation, to perform the following operating system upgrades to the CPM without changing the accreditation status of the CPM ISSP during the upgrade period: Domain Controllers; Backup Services; and File Servers. Amendment 72 to License Condition 10(z) for Materials License SNM-2010 has been updated to reflect this revision, and the amended license is enclosed.

This authorization is subject to the following stipulation:

UUSA shall complete the upgrades within 14 days of the date of this letter, and submit the Security Assessment Report for the CPM to NRC, for transmittal to DOE-NE-ORSO, for review and reaccreditation within 30 days of completion.

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of NRC's ADAMS. ADAMS is accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.
