6. Purposes for Which Licensed Material Will Be Used

Purpose(s) for which licensed material will be used.
A & B: To be used in Troxler Model 3400 series gauges for measurement of physical properties of materials.

Item 7: Radiation Safety Officer

The name of the RSO is Nick Lococo.

The proposed RSO has successfully completed adequate training as described in the NUREG 1556, Volume 1 Guide. Future RSO's will likewise complete this training.

Item 8: Training for Individuals Working In or Frequenting Restricted Areas

Before using licensed materials (gauges), authorized users will have successfully completed training as described in NUREG 1556, Volume 1.

Item 9: Facilities and Equipment

No response required for this item on the application. Compliance with security, posting, and public dose requirements will be verified during inspections.

Item 10: Radiation Safety Program

10.1 Personnel Monitoring: All personnel will wear a personnel monitoring device, such as a TLD badge, to measure radiation exposure when using or transporting gauges. The badges shall be exchanged at intervals not to exceed three months. Dosimetry badges shall be provided by a vendor accredited by the National Voluntary Laboratory Accreditation Program (NVLAP).

10.2 Radiation Detection Instruments: We will possess and use or have access to a survey meter for use in the event of an incident involving the gauge. The survey meter will be calibrated annually by the manufacturer and will meet

the criteria in NUREG-1556, Vol.1, Rev.1.

10.3. Sealed Source Leak Testing: Leak tests will be performed at intervals not to exceed 12 months using an approved kit in accordance with the kit supplier's instructions. Leak test samples will be analyzed by an organization authorized by the NRC to provide leak test services.

10.4. Material Receipt and Accountability: Records of receipt, transfer, and disposal of gauges will be maintained for at least three years. Physical inventories will be conducted at intervals not to exceed six months, to account for all sealed sources and devices received and possessed under this license.

10.5. Public Dose: No response is required from the applicant in a license application, but this matter will be examined during an inspection.

10.6. Operating and Emergency Procedures: Operating and emergency procedures will be developed, implemented, and maintained, and will meet the criteria in the section entitled 'Radiation Safety Program Operating and Emergency Procedures' in **NUREG- 15 56**, Vol. **1**, 'Consolidated Guidance about Materials Licenses: Program-Specific Guidance about Portable Gauge Licenses,' May 1997.

10.7. Maintenance: We will implement and maintain procedures for routine maintenance (cleaning and lubrication) of our gauges according to the manufacturer's recommendations and instructions. We will send the gauge to the manufacturer to perform non-routine maintenance or repair operations that require removal of the source or source rod from the gauge.

10.8. Transportation: No response is needed from applicants during the licensing process; this issue will be reviewed during inspection.
