SUBJECT: ALLEGATION PROGRAM CY 2015 ANNUAL TRENDS REPORT

In accordance with Management Directive 8.8, "Management of Allegations," dated January 29, 2016, the Agency Allegation Advisor is to offer the Executive Director for Operations an independent annual report analyzing allegation trends. A copy of the annual trends report for calendar year 2015 is enclosed.

The report analyzes national, regional, and site-specific trends in allegation data. From a national perspective, the number of allegations received last year increased by about 15 percent in large part due to concerns raised about construction site activities associated with new reactors. The analyses also provide insights into the safety conscious work environment at five operating reactor sites, two reactor sites under construction, and two vendor sites. In cases where the trends are indicative of a weakening safety conscious work environment, the Nuclear Regulatory Commission staff has engaged the licensee and is closely monitoring its activities to address the weaknesses.
