The focus of the meeting was to provide members of the public an opportunity to ask questions about the NRC's purpose and responsibilities, and to discuss any regulatory issues. The discussion covered the Reactor Oversight Process (ROP), the role of the NRC resident inspector, River Bend Station's position in the ROP Action Matrix, and the appropriate level of NRC regulatory response based on River Bend Station's position in the ROP Action Matrix.

This Category 3 public meeting was attended by one member of the public, one representative for Senator Vitter, one representative for Senator Cassidy, two people from the Louisiana Department of Environmental Quality, one person from the Governor's Office of Homeland Security, and eight people from Entergy.
