Dear Ms. Sepulveda:

Teledyne API is planning to transfer to a new location approximately four miles from our existing facility during July 2016. In accordance with NUREG 1556, Vol. 3, Rev. 2, Chapter 13.6, Teledyne API asks to transfer our SSDR certificate (NR-1335-D-101-E) and Material License (04-23983-01E) to the new location.

The new facility will become the sole site of *Teledyne API, a business unit of Teledyne Instruments, Inc.* and will be located at 9970 Carroll Canyon Road, Suite A, San Diego, CA 92131. The device manufacturer remains the same but the distribution location will change to the 9970 Carroll Park Drive site during July. All commitments by Teledyne API remain in force. There is no change of ownership with the move and all processes and personnel will remain the same. There is no change in labeling. Additionally, no changes have been made to the product since its initial registration or last amendment.

As of this date, the serial number of the last unit that was distributed at our previous location was 184. As our serial numbers are non-consecutive, a list of all serial number distributed from 9480 Carroll Park Drive is provided in Attachment A. Teledyne API does anticipate deliveries of units from our 9480 Carroll Park Drive location until our move, and we will amend Attachment A accordingly. We will also advise of the number of units and sources that were transferred to the new location when Attachment A is amended.

We have acquired an amended possession license (7790-37) with the State of California RHB to allow transfer of our activities to the new location. We trust this provides the information needed to revise SSDR NR-1335-D-101-E and Materials License 04-23983-01E.
