
The license condition requires the Licensee to "complete the analysis of the as-designed individual piping segments and shall inform the Director of NRO, or the Director's designee, in writing, upon the completion of these analyses and the availability of the design reports for the selected piping packages."

The purpose of this letter is to notify the Nuclear Regulatory Commission (NRC) that the analysis for this package meeting the criteria identified in AP1000 DCD, Rev. 19, Section 3.9.8.7, is complete and available for NRC inspection:
