Good morning Phil,

I talked to Steve Ruffin, my supervisor, about your proposed approach to address the second round of RAIs related to the revision request of the Model No. BRR. Based on the conversation with Steve, these are the options:

1. A phone call to BRIEFLY discuss the proposed responses to you to determine if you are on the right path. Detail discussions about proposed responses would require a public meeting.
2. A public meeting in the near future to discuss the proposed responses to the second RAI. This meeting can occur over the phone or in person. Based on the applicable staff and management MS Outlook Calendars (as well as room availability), the following dates and times may work for a public meeting :
  - a. May 4 from 1-3PM
  - b. May 5 from 1-3PM

I need to verify with the staff if their calendars are up-to-date, but I wanted to give you the opportunity to have some dates and times to work with, in case you decide having a public meeting. (The reason for proposing a public meeting is that this may be a venue that can be used for more detailed technical discussions and may be beneficial for both parties in terms of the use of time and resources. Just something to consider.)

If you decide going on the public meeting route, I need to know your decision and a high-level agenda by NLT 4/19/16, since public meetings are noticed 10 calendar days in advance from the meeting date. (I also need to know if this will be an open or partially closed meeting.)

Feel free to contact me if you have questions about the proposed approach. I am planning to work from home today until 11:15am (EST) and all day on Monday. I should be in the office next week.
