CROOK COUNTY, WYOMING (PROJECT NUMBER: 0116RLC002)

Dear Ms. Hopkins:

On December 31, 2015, the U.S. Nuclear Regulatory Commission (NRC) submitted a Class III Archeological Survey Report for Strata Energy, LLC's (Strata) Kendrick expansion of its Ross site for the Wyoming State Historic Preservation Office's (WY SHPO) concurrence. The Kendrick Class III report included several archeological sites noted as "unevaluated." With this letter, the NRC is submitting a National Register of Historic Places evaluation plan for 13 "unevaluated" Kendrick sites for the WY SHPO's concurrence. The NRC is asking for your concurrence within 30 days, or sooner if possible, since Strata intends to conduct the necessary Kendrick field activities in the early summer timeframe.

The archaeological sites, all prehistoric/pre-contact in age, are proposed for formal testing for evaluation, unless otherwise noted. The enclosed evaluation plan includes the following sites:
