SUBJECT: SUMMARY OF THE OCTOBER 29, 2015, PUBLIC MEETING WITH
DOMINION VIRGINIA POWER TO DISCUSS NORTH ANNA
COMBINED LICENSE APPLICATION COLA TOPICS

On October 29, 2015, a Category 1 public meeting was held between the U.S. Nuclear Regulatory Commission (NRC) Staff and Dominion Virginia Power (Dominion) regarding the North Anna Unit 3 Combined Operating License Application submitted on December 18, 2013. The topics for discussion during this meeting included the "Follow-up Actions from NRC Audit 1 Updated 10/22/2015" (Agencywide Documents Access and Management System Accession No. ML16124A943), along with discussions on NRC staff general questions and other issues related to the ongoing safety review of the North Anna 3 application.

The meeting commenced at approximately 2:00 p.m. with NRC staff opening remarks, an introduction of attendees, and an announcement of meeting logistics. The following issues were discussed:

- Dominion feedback from October 14, 2015, meeting on final safety analysis report (FSAR) text consistency with respect to Dominion's response to Request for Additional Information (RAI) 02.04.02-15. Dominion would send in a revised RAI response per the discussion.
