In accordance with 10 CFR 50.4(b)(4), "Security plan and related submissions," and 10 CFR 50.54(p)(2), "Conditions of licenses," NextEra Energy Seabrook, LLC submits Revision 21 to the Seabrook Station Physical Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan.

The Physical Security Plan has been revised to reflect the following changes:
