SUBJECT: BROWNS FERRY NUCLEAR PLANT, UNITS 1, 2, AND 3 – REQUEST FOR
WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE
(CAC NOS. MF6741, MF6742, AND MF6743)

Dear Mr. Shea:

By letter to the U.S. Nuclear Regulatory Commission (NRC), dated November 13, 2015 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML15317A361), Tennessee Valley Authority submitted an affidavit dated November 9, 2015, executed by Mr. Alan B. Meginnis, Manager, AREVA, Inc. (AREVA), requesting that the information contained in the following proprietary document (Enclosure 1 of the letter dated November 13, 2015) be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

- FS1-0024530, Revision 1, "Browns Ferry EPU [Extended Power Uprate] Low Flow Issues Impact," November 2015.

A nonproprietary copy of document FS1-0024530, Revision 1 (Enclosure 2 of the letter dated November 13, 2015), entitled "Browns Ferry EPU Low Flow Issues Impact," November 2015 (Non-Proprietary), has been placed in the NRC's Public Document Room and added to the NRC Library in the ADAMS (Accession No. ML15317A361).

The AREVA affidavit dated November 9, 2015, stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (b) Use of the Information by a competitor would permit the competitor to significantly reduce its expenditures, in time or resources, to design, produce, or market a similar product or service.
- (d) The Information reveals certain distinguishing aspects of a process, methodology, or component, the exclusive use of which provides a competitive advantage for AREVA in product optimization or marketability.
- (e) The information is vital to a competitive advantage held by AREVA, would be helpful to competitors to AREVA, and would likely cause substantial harm to the competitive position of AREVA.
