Clarification questions on SCE&G submittals NND-15-0467 and NND-16-0109

1. NND-15-0467, Enclosure 6, Page 2 of 77 – The first paragraph of the “Background” section states that an individual, and aggregate assessment of the impact of the 33 newly identified simulator discrepancy items was conducted....

Is 33 the correct number? It appears to conflict with the previous sentence. If 33 is correct, what reduced the discrepancies evaluated from 66 to 33?

2. NND-15-0467, cover letter, page 2 of 5, - Patch Post-Fix Test Plan

Have all actions in the test plan been completed? Is NND-16-0109 serving as notice that the testing is complete and if so which parts?

3. NND-15-0467, Enclosure 6, Page 5 of 77 says VC-1506-01 is being corrected and table E9-1 of NND-16-0109 confirms it is now closed. Page 6 says this SDR was combined with VC-TO-103.

Why is this listed as being corrected in one paragraph then “combined and tracked” in a subsequent paragraph? (Similar paragraph shows up again on page 7-8)

4. NND-15-0467, Enclosure 6, Page 12 of 77 – VC-1507-53 is listed as being closed. Table E9-1 of NND-16-0109 lists it as open.

What is the actual status?

5. NND-15-0467, Enclosure 6, Page 19 of 77 – VC-1507-43 is listed as being open. Table E9-1 of NND-16-0109 lists it as closed.

What is the actual status?

6. NND-15-0467, Enclosure 6, Page 21 and 32 of 77 – VC-TO-102 is listed as being closed. Table E9-1 of NND-16-0109 lists it as open.
