**SUBJECT: SUMMARY OF APRIL 27, 2016, PUBLIC MEETING WITH LOUISIANA
ENERGY SERVICES, LLC - LICENSEE PERFORMANCE REVIEW**

Dear Mr. Laughlin:

On April 27, 2016, a Category 1 public meeting was held between the U.S. Nuclear Regulatory Commission (NRC) and representatives of Louisiana Energy Services, L.L.C. at the Eunice Community Center, 906 12th Street, Eunice, New Mexico. The purpose of the meeting was to discuss the results of the NRC's assessment of URENCO USA's safety performance for the review period of January 1, 2014, through December 31, 2015. The meeting notice and agenda, dated April 12, 2016, are available in the NRC's Agencywide Documents Access and Management System (ADAMS) at Accession No. ML16103A338. A list of attendees is enclosed.

The NRC staff presented its evaluation of your safety performance in the areas of operations and construction, as discussed in the March 3, 2016, letter (ADAMS Accession No. ML16064A001) (See ADAMS Accession No. ML16123A180).

The licensee presented information on the site's progress and compliance with each performance area: Safety Operations, Radiological Controls, Facility Support, and Safeguards (See ADAMS Accession No. ML16123A179).

Member of the public were in attendance. There were no public meeting feedback forms received.
