The NRC staff responses to the applicant comments are documented in a meeting summary memorandum (Reference 3).

Also during that meeting, FPL agreed to provide a letter regarding its position on the NRC staff proposed license conditions. FPL concurs with the proposed generic AP1000 license conditions identified in Reference 2, as modified in Reference 3, for the Turkey Point Units 6 & 7 COLs. FPL understands, based on Reference 3, that the proposed condition 1-1 in Reference 2 is not a license condition but rather a series of authorizations, and will be treated similar to how they were treated for the V.C. Summer Unit 2 COL.
