Dear Dr. Zhang:

Enclosed is Amendment No. 121 to your NRC Materials License No. 13-01284-02 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

Thank you for notifying us of the reconstruction of your PET facility as described in your letter dated February 2, 2016. Please note that based on the information provided in the aforementioned letter, that area is decommissioned for unrestricted use; however, we have not removed the location of use from your license since this is a temporary measure. Therefore, you will need to notify us when the construction is completed and you resume licensed activities in that area. This was also discussed by you and I by telephone on May 6, 2016.

Also, please note that, as requested in your letter dated February 29, 2016, we have removed several authorized users from your license. Lastly, as requested in your letters dated March 21 and April 12, 2016, we have increased Dr. Russell's authorizations and added Dr. Cannon as an authorized user, respectively.

Please review the enclosed documents carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.


