Good Morning Tim: Thank you very much for your prompt response. You're so welcome! Please address the following for your renewal of your license and update the application and Appendix B accordingly.

1. The 3rd thing was under quantity column for Items 5 and 6, tell me the maximum number of gauges you want to be authorized.
2. In addition, on page 3 of the application, Appendix B, at the end of Items 5 and 6, check either the yes or no box [the appropriate response will be “no” since the quantity of gauges you possess will be less than the quantity required to submit financial assurance] for “financial assurance required and evidence of financial assurance provided”.
3. Please expand the text of your operating and emergency procedures to include the following text: “operating, emergency and security procedures described in the errata sheet to Appendix H of NUREG-1556, Vol. 1, Rev. 1.

Once you have updated your renewal application and Appendix B accordingly in response to the above, I will if you'd like me to review your renewal submittal again before finalizing your renewal application for review.
