SUBJECT: RE-INITIATION OF FORMAL SECTION 106 CONSULTATION PURSUANT  
TO THE NATIONAL HISTORIC PRESERVATION ACT REGARDING THE  
CAMECO RESOURCES LICENSE RENEWAL APPLICATION FOR  
THE SMITH RANCH PROJECT

Dear Chairman Flying Hawk:

By letter dated February 1, 2012, Power Resources, Inc. (doing business as Cameco Resources [Cameco]) requested renewal of U.S. Nuclear Regulatory Commission (NRC) source material license SUA-1548. This license authorizes Cameco to conduct uranium in-situ recovery (ISR) operations at its Smith Ranch Project. The project includes existing and planned ISR activities at the following locations: (1) the Smith Ranch, Highland, and Reynolds Ranch properties in Converse County, Wyoming; (2) the Gas Hills property in Fremont and Natrona Counties, Wyoming; (3) the North Butte property in Campbell County, Wyoming; and (4) the Ruth property in Johnson County, Wyoming. A map showing the general locations of these properties is provided as Enclosure 1.

By letter dated December 31, 2012, the NRC invited the Yankton Sioux Tribe to participate as a consulting party under Section 106 of the National Historic Preservation Act (NHPA) in regards to the NRC's undertaking to renew source material license SUA-1548. Your Tribe expressed its interest at that time in being a consulting party. Therefore, the purpose of this letter is to notify you that the NRC is re-initiating the NHPA Section 106 consultative process and inform you of the current status of the NHPA Section 106 process of NRC's review of Cameco's application. This same letter is being sent to 26 other Native American Tribes, who also received the initial December 31, 2012, consultation inquiry.

The NRC accepted Cameco's license renewal application for detailed technical review on July 5, 2012, and issued a request for additional information (RAI) to Cameco on May 2, 2013. Cameco completed submitting its response to the RAIs on April 21, 2015. Cameco's RAI response included updated sections of the license renewal application. The NRC staff is now in the process of reviewing Cameco's responses for completeness and adequacy. By letter dated August 18, 2015, the NRC proposed an Area of Potential Effect (APE) to the Wyoming State Historic Preservation Office (WY SHPO). This APE was revised in response to WY SHPO comments, and by letter dated September 8, 2015, the WY SHPO concurred on the revised APE. Copies of the NRC's letter and the WY SHPO's concurrence are provided as Enclosures 2 and 3 to this letter.

The EA will include analyses of potential impacts to historic and cultural resources, and to inform that analysis, the NRC staff is collecting information to facilitate the identification of historic properties, including those that may be of religious and cultural significance to the Tribes.
