

On November 10, 1979 your office was informed of an Oconee 3 incident involving a loss of power to the Integrated Control System. During the course of that incident, Reactor Coolant System cooldown limits were exceeded. Therefore a report was to have been submitted by November 23, 1979 pursuant to Oconee Nuclear Station Technical Specification 6.6.2.1.a(2). However, investigation of the incident has not been completed. It is anticipated that Reportable Occurrence Report RO-287/79-13 providing additional details of the incident will be submitted no later than November 30, 1979.
