SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE
FOR THE ST. LUCIE PLANT, UNIT NOS. 1 AND 2 (CAC NOS. MF7269 AND
MF7270)

Dear Mr. Nazar:

By letter dated May 6, 2016 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16133A045), Florida Power & Light Company (the licensee) submitted an affidavit dated March 29, 2016, executed by James A. Gresham, on behalf of Westinghouse Electric Company LLC., requesting that information contained in the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Section 2.390.

"St. Lucie Units 1 and 2 ANC8 ITC Bias"

A non-proprietary version of this document is publicly available under ADAMS Accession No. ML15314A161.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- 4(ii)(a) The information reveals the distinguishing aspects of a process (or component, structure, tool, method, etc.) where prevention of its use by any of Westinghouse's competitors without license from Westinghouse constitutes a competitive advantage over other companies.
- 4(ii)(b) It consists of supporting data, including test data, relative to a process (or component, structure, tool, method, etc.), the application of which data secures a competitive economic advantage, e.g., by optimizing or improved marketability.
- 4(ii)(c) Its use by a competitor would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing a similar product.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavits, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.
