NUCLEAR MATERIALS LICENSE SNM-1107 (COST ACTIVITY CODE: L33317)

Dear Ms. Parr:

While performing their technical review of a request to renew special nuclear materials license SNM-1107, transmitted by letter dated December 17, 2014, the staff at the U.S. Nuclear Regulatory Commission (NRC) have identified additional information that is needed to complete their review. By letter dated May 18, 2016, the NRC staff had sent a request for additional information (RAI) regarding management measures. The enclosed RAIs pertain to the remaining topics of the review of the application to renew license SNM-1107.

The additional information, specified in the enclosure, should be provided within 30 days from the date of this letter.

Pending the additional information, which answers the RAIs, the NRC staff anticipates completing the subject licensing activity by the end of December 2016; this date could change depending on the findings of this technical review, urgent assignments, or other factors. The NRC staff will promptly communicate any significant changes to this schedule.

In accordance with Title 10 of the *Code of Federal Regulations*, Section 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records System component of the NRC's Agencywide Documents Access and Management System (ADAMS).
