SUMMARY

By letter dated March 4, 2016 BWXT, Nuclear Operations Group, Inc. requested an amendment to Certificate of Compliance No. 9250, for the Model No. 5X22 transportation package. The letter requested name changes to the subject certificate of compliance due to a recent company name change. The certificate has been updated to Revision No. 13 to reflect the changes.

EVALUATION

The purpose of the amendment was to change the name of the entity the certificate of compliance is issued to from "Babcock and Wilcox Nuclear Operations Group, Inc." to the new name "BWXT Nuclear Operations Group, Inc." BWXT also submitted a copy of the consolidated Safety Analysis Report for Packaging (SARP) for the Model No. 5X22. Revisions to the SARP included company name changes and two corrections noted in the March 4, 2016 letter.

These changes do not affect the ability of the package to meet 10 CFR Part 71 requirements.

CONDITIONS

The following changes have been made to the certificate of compliance:

Section 3.a. of the certificate of compliance has been revised to reflect the new name of the certificate holder and applicant, "BWXT Nuclear Operations Group, Inc." as requested.

Section 5(a)(3) has been revised to reflect the current revision numbers of Drawing Nos. 1220276 E, Rev. 6, and 1220277 E, Rev. 10. The drawings were changed to reflect the new name of the certificate holder and applicant, "BWXT Technologies, Inc."

Section 5.(b)(4) has been revised to reflect the new name of the certificate holder and applicant, "BWXT Technologies, Inc."

"As supplemented" was removed from Section 7.(a)

Condition 11 now allows use of Revision No. 12 of the certificate until June 30, 2017.

The References section has been updated to include the name change request.

CONCLUSION

Based on the statements and representations in the amendment request, the staff finds that these changes do not affect the ability of the package to meet the requirements of 10 CFR Part 71.
