Arnie Morel made no changes to the placement or location of the ladder Mr. Chastain had been using prior to taking pictures.

ADMISSION NUMBER 6

Arnie Morel made no changes to the placement or location of the Amersham 600B camera that Mr. Chastain had been using prior to taking pictures.

ADMISSION NUMBER 7

Conan Exhibits number two and three introduced by counsel for Conan at the deposition of William Chastain taken on May 12, 1998 are prints of pictures taken by

Arnie Morel on February 27, 1996, in the room where Mr. Chastain thought he had been overexposed to radiation.


