SUBJECT: SUMMARY OF TELECONFERENCE TO DISCUSS OPEN ITEMS
ASSOCIATED WITH THE REVIEW OF THE ADVANCED BOILING-
WATER REACTOR CERTIFICATION RENEWAL

On Thursday, May 19, 2016, the U.S. Nuclear Regulatory Commission's staff held a teleconference with members of GE Hitachi Nuclear Energy (GEH) to discuss responses to requests for additional information (RAIs) and open items associated with the review of the advanced boiling-water reactor certification renewal. Specifically, the following items were discussed:

1. Suction strainer chemical effects RAI 06.03-2:
 - a. Based on an April 6, 2016 meeting, the staff gave GEH feedback on their proposed response to the RAI. The staff recommended that the applicant clearly address and justify the different types of material corrosion issue.
 - b. The staff recommended that the applicant address how the standby liquid control system is controlled.
 - c. GEH proposed that a COL Item would evaluate debris loads.
 - d. GEH stated that they planned to submit a final response by June 10, 2016.
