Memorandum and Order

On December 23, 1998, the NRC Staff issued an immediately effective order suspending the material license of Special Testing Laboratories, Inc. That same date the Licensee requested a hearing and moved to set aside the immediate effectiveness order. On December 29, 1998, the Secretary of the Commission forwarded the hearing request to the Chief Administrative Judge for appropriate action and on that same day this Licensing Board was established to preside over the proceeding.

The Licensing Board held a telephone conference with the parties on December 30, 1998 and was informed that the parties had reached a tentative agreement to settle the immediate effectiveness aspect of the Staff's enforcement order. The parties further indicated that they needed additional time to finalize the agreement and requested that the Board take no



action at the present time with respect to the immediate effectiveness aspect of the enforcement order. The Board then scheduled a second telephone conference for January 4, 1999.

At the second telephone conference, the parties informed the Board that they were still finalizing an agreement on the immediate effectiveness aspect of the enforcement order and that the settlement likely would take the form of an amended order by the Staff. The parties further informed the Board that they also would undertake discussions concerning the settlement of the entire proceeding and requested that the Board continue to take no action. The parties also agreed to report their progress toward settlement of the proceeding in another telephone conference. That telephone conference shall take place at 10:00 a.m., January 19, 1998.
