SUBJECT: SUMMARY OF A PUBLIC MEETING WITH SOUTHERN NUCLEAR
OPERATING COMPANY AND SOUTH CAROLINA ELECTRIC & GAS
ON MAY 12, 2016

The U.S. Nuclear Regulatory Commission (NRC) staff held a Category 2 public meeting with Southern Nuclear Operating Company (SNC) and South Carolina Electric & Gas (SCE&G) on May 12, 2016. The purpose of the meeting was to discuss issues associated with the safety review of licensing actions for SNC's Vogtle Electric Generating Plant (VEGP) Units 3 and 4, and SCE&G's Virgil C. Summer Nuclear Station (VCSNS) Units 2 and 3.

Summary of Meeting:

On May 12, 2016, staff from the NRC conducted a public meeting with representatives from SNC and SCE&G to discuss issues associated with the safety review of licensing actions for SNC's VEGP Units 3 and 4, and SCE&G's VCSNS Units 2 and 3. Specifically, the meeting discussed (1) SNC's draft LAR on PMS logic change for source-range flux doubling, (2) NRC staff draft RAIs for V.C. Summer, Units 2 and 3 proposed EAL scheme change, and (3) an NRC staff clarification question regarding SCE&G's request for a Commission-Approved Simulation Facility (CAS).

The first discussion topic was SNC's draft LAR on PMS logic change for source-range flux doubling. SNC described the differences between their draft LAR submittal and the submittal by Duke Energy Carolinas, LLC, for the William States Lee III Nuclear Station Units 1 and 2, presented in Section 4.2, "Precedent," of SNC's draft LAR. SNC noted that the design changes are identical to Duke's submittal for compliance with the requirements in Institute of Electrical and Electronics Engineers (IEEE) 603-1991. SNC stated that the differences consist of RAI responses being incorporated into VEGP Units 3 and 4 Updated Final Safety Analysis Report and editorial differences for consistency and to convey the Technical Specification requirements. The staff noted that they understood the differences and would perform a detailed review when the LAR is formally submitted.

The second discussion topic was to discuss draft RAIs related to the SCE&G application dated December 1, 2015 (ADAMS Accession No. ML15335A448), requesting approval for an EAL scheme change for the VCSNS, Units 2 and 3. The discussion primarily focused on gaining mutual understanding for RAI-VCSNS-01, RAI-VCSNS-02, and RAI-VCSNS-11. For RAI-VCSNS-01, it was stated that engagement with NEI may be necessary to address this RAI. SCE&G stated that they understood the remaining RAI questions and that they did not need additional clarification to understand what the staff was requesting.

The third discussion topic was to discuss an NRC staff clarification question regarding how the simulator discrepancies were categorized in SCE&G's request for a CAS. SCE&G provided the clarifications necessary for the staff to continue the review of SCE&G's request for a CAS.

At the end of each discussion topic, there was an opportunity for the public to provide comments and ask questions. All comments and questions were addressed before ending the meeting.
