PURPOSE: To conduct a mediation session as part of the agency's alternative dispute resolution program related to two apparent violations of NRC regulations. Specifically, employees of Acuren USA failed to conspicuously post high radiation warning signs in an area while radioactive materials were being used and failed to maintain continuous visual surveillance of that area while work was being performed to prevent unauthorized entry.
