SUBJECT: NRC CONSENT TO DIRECT LICENSE TRANSFER AND AMENDMENT NO. 27

Dear Mr. Andrzejewski:

By letters dated March 2, 2016 (received at the U.S. NRC Region III office on March 3, 2016), and May 23, 2016 (received at the U.S. NRC Region III office on May 23, 2016), Alpena Regional Medical Center submitted to the U.S. Nuclear Regulatory Commission (NRC) Region III Office a Request for Consent to direct License Transfer of NRC Materials License No. 21-17754-01. Based on the information provided, we understand that as a result of a proposed acquisition of Alpena Regional Medical Center, control would be directly transferred to MidMichigan Health of Midland, Michigan. We further understand that this transfer will not result in any change to the licensed materials, persons using the license material, location of use of licensed material, or persons responsible for the licensee's radiation safety program. Based on information provided, we understand that, on April 1, 2016, all of Alpena Regional Medical Center's assets and operations were directly transferred to MidMichigan Health of Midland, Michigan, and resulted in a name change to MidMichigan Medical Center-Alpena. We have updated the license accordingly.

Enclosed is Amendment No. 27 to your NRC Material License No. 21-17754-01 in accordance with letter dated May 23, 2016, confirming that the transaction has been completed as described. We have also updated Item 12.B. to reflect Dr. Ajay Puri's medical doctor physician licensure with the state of Michigan. Changes made to your license are printed in **bold font**.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.


You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

Based on the above understandings and as more fully detailed in the enclosed NRC staff's Safety Evaluation Report which documents the NRC staff's review of the request, we have no objection to the proposed transfer.
