This refers to your license amendment request. Enclosed with this letter is the amended license removing the requested authorized users. The request to add PET isotopes for use in hot cells has not been added at this time. Please review the guidance found in NUREG-1556, Vol. 13 for information to provide for radiopharmacy operations involving PET production. Additionally, if you will be operating a cyclotron or included in a consortium for the operation of a cyclotron, please review the guidance found in NUREG-1556, Vol. 21 for the information to provide.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers. You may contact me at 610-337-5169 for specific questions related to the licensing of PET operations.
