FEDERAL REGISTER NOTICE – REQUEST FOR COMMENTS ON THE DRAFT REVISIONS TO THE “POLICY STATEMENT FOR THE AGREEMENT STATE PROGRAM” – (NRC-2016-0094) (STC-16-044)

**Purpose:** To provide notification that the U.S. Nuclear Regulatory Commission (NRC) has published a *Federal Register* notice (FRN) that is soliciting comments on the proposed Policy Statement for the Agreement State Program.

**Background:** The NRC has revised and consolidated two policy statements on NRC’s Agreement State Programs: the “Policy Statement on Adequacy and Compatibility of Agreement State Programs” and the “Statement of Principles and Policy for the Agreement State Program.” The Commission approved NRC staff’s proposed plan to provide the consolidated policy statement in the Staff Requirements Memorandum (SRM) to COMSECY-14-0028, dated August 12, 2014 (Agencywide Documents Access and Management System (ADAMS) Accession No: ML14224A618). The proposed consolidated policy statement also addresses the Commission direction in the SRMs to SECY-10-0105 (ADAMS Accession No: ML103360262) and SECY-12-0112 (ADAMS Accession No: ML13148A352) to update the Policy Statement on Adequacy and Compatibility of Agreement State Programs to include both safety and source security considerations in the determination process, and publish the draft revisions of the policy statements for public comment. The proposed policy statement also reflects written public comments and input received from public meetings and the Organization of Agreement States topical session.
