SIRA Imaging Center, LLC would like to terminate its Byproduct Materials License, Number 13-24646-02. We request that all licensed activities be transferred to the Byproduct Materials License of Indiana University Health – Bloomington Hospital, Number 13-10408-02, with no interruption of licensed activities. Enclosed is NRC Form 314.

1. There will be no changes in personnel or duties in regards to the transfer of licensed activities.
2. There will be no changes in the organization, location, facilities, equipment, or procedures that relate to the licensed program.
3. The surveillance program that is currently in place complies with USNRC regulations. Daily radiation surveys, weekly radioactive contamination surveys, quarterly sealed source inventory and leak tests, and personal dosimetry are currently performed. The transfer of licensed activities will not alter the current surveillance program.
4. We confirm that all records concerning the safe and effective decommissioning of the facility will be maintained at the current address of use listed on License Number 13-24646-02. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity. If licensed activities are terminated in the future at the address of use, the records will be transferred to 13-10408-02 or the USNRC, as appropriate.
5. We confirm that licensed activities will abide by all constraints, conditions, requirements, and commitments of 13-10408-02.
