SUBJECT: SUMMARY OF THE JUNE 7, 2016, PUBLIC MEETING WITH
DOMINION VIRGINIA POWER TO DISCUSS NORTH ANNA
COMBINED LICENSE APPLICATION COMBINED LICENSE
APPLICATION TOPICS

On June 7, 2016 a Category 1 public meeting was held between the U.S. Nuclear Regulatory Commission (NRC) staff and Dominion Virginia Power (Dominion) regarding the North Anna Unit 3 Combined Operating License Application submitted on December 18, 2013. The topic of discussion was Request for Additional Information (RAI) 01-6.

The meeting commenced at approximately 2:00 p.m. with NRC staff opening remarks, an introduction of attendees, and an announcement of meeting logistics. The following issues were discussed:

- The NRC staff gave Dominion feedback on their draft RAI response (Attachment 1) which included some minor editorial suggestions to the proposed license conditions. The NRC staff followed up the meeting with an email describing these edits (Attachment 2).
- The NRC staff suggested that the applicant consider revising their RAI response to include a discussion regarding attaching a license condition to the secondary insurance requirements specified under Title 10 *Code of Federal Regulations* 140.11(a)(4).
- Dominion planned to submit a final RAI response by June 17, 2016.
