SUBJECT: QUARTERLY UPDATE – INTEGRATED SCHEDULE OF
MAJOR REGULATORY ACTIVITIES FOR FUEL CYCLE
FACILITIES

Enclosed is the update to the integrated schedule of major regulatory activities for fuel cycle facilities. "Integrated Schedule of Regulatory Activities for Fuel Cycle" (Agencywide Documents Access and Management System [ADAMS] Accession No. ML16161A371) is a chart that lists the current regulatory activities, the major milestones, dates for meetings and public interactions, and the drivers. "Supplement to the Fuel Cycle Integrated Schedule" (ADAMS Accession No. ML16161A368) provides additional information on regulatory activities listed on the Gantt chart. The document contains a purpose statement for each activity, an overview of the project's status, a list of related documents, and information on the public interactions scheduled. Major changes to the integrated schedule are described below.

Title 10 of the *Code of Federal Regulations* (10 CFR) Part 20, "Standards for Protection Against Radiation" Rulemaking

As directed by SRM-SECY-16-0009, "Recommendations Resulting from the Integrated Prioritization and Re-Baselining of Agency Activities" (ADAMS Accession No. ML16104A158), the Commission discontinued the 10 CFR Part 20 rulemaking activities. Therefore, this activity was removed from the integrated schedule.

10 CFR Part 21, "Reporting Defects and Non-Compliance" Rulemaking

The 10 CFR Part 21 rulemaking effort was discontinued by the Commission decision on budget re-baselining. As directed in SRM-SECY-16-0009, the Commission approved the staff's

recommendation to continue with guidance development using the existing regulatory requirements. That draft guidance is entitled Draft Guide (DG)-3049, "Reporting of Defects and Noncompliance for Fuel Cycle, Materials, Waste Disposal, Packaging and Transportation, Independent Storage, and Non-Power Reactor Licensees." Therefore, 10 CFR Part 21 rulemaking was removed from the integrated schedule and DG-3049 development was added.

10 CFR Part 26, "Fitness for Duty" Rulemaking

As directed by SRM-SECY-16-0021, "Discontinuation of Rulemaking Activities" (ADAMS Accession No. ML16141A044), the Commission discontinued the rulemaking activities for 10 CFR Part 26. The staff reviewed the proposed alternative to rulemaking which would add fatigue measures for security officers at Category I facilities. The staff considers the proposal a suitable option for the two Category I facilities. The staff is working with the Category I facilities to adopt the proposed measures into their physical protection plans. Therefore, 10 CFR Part 26 rulemaking was removed from the integrated schedule.

Revised Fuel Cycle Oversight Process (RFCOP)

In SRM-SECY-16-0005, "Cornerstone Development for the Revised Fuel Cycle Process" (ADAMS Accession No. ML16102A433), the Commission directed the staff to stop further development of a RFCOP. Therefore, this activity was removed from the integrated schedule.
