SUBJECT: SUMMARY OF MAY 26, 2016, PUBLIC MEETING WITH NUSCALE  
POWER, LLC TO DISCUSS MITIGATION OF BEYOND DESIGN  
BASIS EVENTS (PROJ0769)

On May 26, 2016, a Category 1 open public meeting was held at the U.S. Nuclear Regulatory Commission (NRC) headquarters office, in Rockville, Maryland, between representatives of the NRC staff and NuScale Power, LLC (NuScale) to discuss topics related to NuScale's small modular reactor (SMR) mitigation of beyond design basis events (Agencywide Documents Access and Management System (ADAMS) Accession No. ML15302A516).

The NRC staff and NuScale discussed topics regarding the overall NuScale SMR design, decay heat removal system, emergency core cooling system, and comments provided to the NRC in the NuScale letter LO-0216-21680, dated November 11, 2016, "NuScale Power, LLC Comments on the Draft Mitigation of Beyond-Design-Basis Events Rulemaking Package" (ADAMS Accession No. ML16048A103), regarding the proposed mitigation of beyond-design-basis event regulation, NRC, "Mitigation of Beyond-Design-Basis Events," *Federal Register*, Volume 80, No. 219, November 13, 2015, pp. 70610 – 70647.

In addition, the following topics on the contents of the proposed NuScale Design Control Document, Chapter 20, "Mitigation of Beyond-Design-Basis Events," Nuclear Energy Institute (NEI) 12-06, "Diverse and Flexible Coping Strategies (FLEX) Implementation Guide," Revision 1A, dated October 2015 (ADAMS Accession No. ML15279A426), core cooling strategy, spent fuel cooling strategy, loss of the ultimate heat sink and the loss of large area strategy were discussed during the meeting. This meeting summary documents the highlights of the discussion.
