Dear Ms. Scott:

On January 20 and 21, 2016, inspectors from the U.S. Nuclear Regulatory Commission (NRC) conducted a routine inspection at your facility in Mount Clemens, Michigan, with continued in-office review through May 9, 2016. The purpose of the inspection was to review activities performed under your NRC license to ensure that activities were being performed in accordance with NRC requirements. In addition, the inspection included a review of the stuck source event at your facility that Elekta, Inc., reported to the NRC on August 19, 2015. The in-office review included a review of documentation of the manufacturer's review of the stuck source event. Mr. Geoffrey Warren of my staff conducted a final exit meeting by telephone with you on May 12, 2016, to discuss the inspection findings.

During this inspection, the NRC staff examined activities conducted under your license related to public health and safety. Additionally, the staff examined your compliance with the Commission's rules and regulations as well as the conditions of your license. Within these areas, the inspection consisted of selected examination of procedures and representative records, observations of activities, and interviews with personnel. No violations were identified during this inspection. No response is required to this letter.
