This is in reference to our letter dated January 22, 2016 transmitting your renewed NRC license. In the letter we stated "This renewal is being issued without completing a review of the Decommissioning Cost Estimate portion of your request because you stated, as part of an electronic correspondence with the NRC, dated January 11, 2016, that the name of your company will change on February 1, 2016". Our intention was that the company name change and updated financial assurance documents would be completed as a single licensing action. Since that time we have not received a request to change the name of your company. Therefore, at this time we have opened an administrative licensing action to request updated financial assurance documents. Please submit the updated financial assurance documents required by 10 CFR 30.35(e)(2).
