Coefficient (MTC) Surveillance Test Elimination at the End of Cycle,” dated January 19, 2016 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16033A472), as supplemented by a letter dated May 6, 2016 (ADAMS ML16133A045).
