Dear Dr. Salacata:

By letter dated March 23, 2016, ARMC Medical Group Cardiology Associates submitted to the U. S. Nuclear Regulatory Commission (NRC) a Notification of Transfer of Control of NRC Materials License No. 21-32378-01. Based on the information provided, we understand that this is an indirect change of control in that the licensee will continue to operate under the auspices of Alpena Regional Medical Center, which was transferred to MidMichigan Health, a non-profit corporation. We further understand that as a result of this change of control, the name for ARMC Medical Group Cardiology Associates will be changed to MidMichigan Medical Center – Alpena.

Based on the above understandings and as more fully detailed in the enclosed NRC staff's Safety Evaluation Report which documents the NRC staff's review of this request, the NRC consents to the indirect transfer of control. Amendment No. 05 amending the licensee name is also enclosed.

The transferee, MidMichigan Health should note their new responsibility and liability as an NRC licensee. Specifically, responsibility is emphasized with regard to any ongoing NRC inspection and enforcement issues, investigations, facility decontamination and decommissioning funding resources. Please be advised, change of ownership/control cannot be transferred without prior written consent from the NRC (10 CFR 30.34 (b)). 
