Hi Karmen,

OK, I did my best. I know we are getting a new and improved method of querying species for this sort of information request. So, within these three townships and the general vicinity:

3 sage-grouse leks

1 Ferruginous Hawk nest

1 Golden Eagle nest

8 Red-tailed hawk nests

The following raptors species have been observed and documented: the three aforementioned nesting species, american kestrel, northern Harrier, prairie falcon, rough legged hawk and bald eagle. These are all species that are common in this general area, so nothing unusual.

I need to contact someone tomorrow to see how can query for other non-game species. Is there anything in particular that you are interested in?

Also, you do have the option of contacting our headquarters and requesting a WOS query for that particular area. This would be the documented observations for the given area. There is a fee associated with this I believe, and I'm not sure what it is. The other thing to mention is that some of the private land and remote areas have had little survey work completed so additional work may be necessary or you would have to assume if suitable habitat is there some spp may occupy it even if they were not documented.
