List of Approved Spent Fuel Storage Casks: Holtec International HI-STORM 100 Cask System; Certificate of Compliance No. 1014, Amendment No. 10, Corrections: Direct Final Rule; Confirmation of Effective Date and Correcting Amendments; Part 72 of Title 10 of the Code of Federal Regulations (10 CFR) (Regulation Identifier Number (RIN) 3150-AJ71; NRC-2015-0270)

On May 31, 2016, the NRC published a document in the *Federal Register* ([81 FR 34241](#)) confirming the effective date of May 31, 2016, for the direct final rule published in the *Federal Register* ([81 FR 13295](#)) on March 14, 2016. This direct final rule amended the NRC's spent fuel storage regulations by revising the Holtec International HI-STORM 100 Cask System listing within the "List of approved spent fuel storage casks" to include Amendment No. 10 to Certificate of Compliance (CoC) No. 1014. In addition, the NRC is correcting the direct final rule because it inadvertently omitted Revision 1 to Amendment Nos. 8 and 9 to CoC No. 1014.

Programmable Logic Computers in Nuclear Power Plant Control Systems: Petition for Rulemaking (PRM); Denial; 10 CFR Part 73 (PRM-73-17; NRC-2013-0214)

On June 1, 2016, the NRC published a document in the *Federal Register* ([81 FR 34916](#)) denying PRM 73-17, submitted by Mr. Alan Morris (the petitioner) on March 14, 2013, as supplemented most recently on December 19, 2013. The petitioner requested that the NRC require that his "new-design programmable logic computers" be installed in the control systems of nuclear power plants to block malware attacks on the industrial control systems of those facilities. In addition, the petitioner requested that nuclear power plant staff be trained "in the programming and handling of the non-rewriteable memories" for nuclear power plants. The docket for the petition, PRM-73-17, was closed on June 1, 2016.
