Subject: Revision 6 to Application for Approval of the Spent Fuel Cask Design for the NUHOMS® EOS System, Revised Response to Questions 3-2 and 4-1 from the Second Request for Additional Information (Docket No. 72-1042, TAC No. L25028)

Reference: (1) Letter from Yen-Ju Chen (NRC) to Paul Triska (AREVA Inc.), "Application for Approval of the Spent Fuel Cask Design for the NUHOMS® EOS System – Second Request for Additional Information, Docket 72-1042, TAC No. L25028," March 3, 2016.

(2) Revision 5 to Application for Approval of the Spent Fuel Cask Design for the NUHOMS® EOS System, Response to Second Request for Additional Information (Docket 72-1042, TAC No. L25028) (AREVA submittal E-44592, transmitted to the NRC on April 7, 2016).

This submittal provides revised responses to two questions provided in Reference 2, as discussed during a followup telephone call meeting with NRC staff on May 5, 2016. The responses to Structural RAI 3-2 and Thermal RAI 4-1 have been revised and supplemented to provide the additional requested information. Enclosure 2, herein, provides a proprietary version of the revised response to these two RAI questions. Enclosure 3 provides a public version of Enclosure 2. Enclosure 4 provides a list of additional changes to the Technical Specifications (TS), Certificate of Compliance (CoC) and Safety Analysis Report (SAR) that are not associated with the RAI. Enclosures 5 and 6 provide a complete update to the proposed CoC and TS, respectively. Enclosure 7 provides the proprietary version of a complete revision to the SAR application, denoted as Revision 6. The public version of Revision 6 to the application is provided as Enclosure 8. Revision 6 changes are tracked with italicized text and revision bars in the right margin to provide NRC staff reviewers with a convenient way to identify the changes made since Revision 5. Note that some of the changes to the SAR associated with these RAI responses were previously made in Revision 5; therefore, no revision bars are associated with these previous changes. Enclosure 9 provides a proprietary version of the list of FLUENT thermal analyses computer files provided in Enclosure 10 that were used for the analyses described in the response to RAI 4-1. Enclosure 11 provides a public version of the list of computer files.

Enclosures 2, 7, 9 and 10 of this submittal include proprietary information, which may not be used for any purpose other than NRC staff review of the application. In accordance with 10 CFR 2.390, an


