SUBJECT: SUMMARY OF THE JUNE 22, 2016, PUBLIC TELECONFERENCE
MEETING TO DISCUSS OPEN ITEMS AND OUTSTANDING ISSUES
RELATED TO THE DOMINION VIRGINIA POWER NORTH ANNA
UNIT 3 PROJECT, COMBINED LICENSE APPLICATION

On June 22, 2016, a Category 1 public teleconference was held between the U.S. Nuclear Regulatory Commission (NRC) and representatives of Dominion Virginia Power (Dominion) regarding the North Anna Unit 3 combined license application (COLA) submitted on December 18, 2013. The meeting notice was issued on May 27, 2016, and was documented in the Agencywide Documents Access and Management System under Accession No. ML16148A091. The purpose of this meeting was for the NRC staff and Dominion staff to discuss, ask questions, or note concerns regarding relevant licensing and technical issues of the North Anna Unit 3 COLA. A list of attendees is provided as an enclosure.

The meeting commenced at 2:00 p.m. with NRC staff opening remarks, an introduction of participants, and an announcement of meeting logistics. Prior to the meeting, Dominion provided a handout with the responses to staff's questions on the draft Final Safety Analysis Report (FSAR) (Revision 9). This handout has been placed in ADAMS.
