Dear Mr. Wohlt:

Enclosed is Amendment No. 87 to your NRC Material License No. 24-01143-06 in accordance with your request. Please note that the major changes made to your license are printed in **bold** font.

Please note, as was discussed in our phone conversation on June 6, 2016, that at this time we are not able to add Dr. Shim for 10 CFR 35.100, 35.200 and 35.1000 for yttrium-90 microspheres based on the information you have provided. If you wish to add these additional authorizations, please provide a NRC Form 313A (AUD) or equivalent for the 10 CFR 35.100 and 35.200. For the request to add him for yttrium-90 microspheres, please refer to "Yttrium-90 Microsphere Brachytherapy Sources and Devices TheraSphere® and SIR-Spheres® Licensing Guidance", Revision 9, dated February 12, 2016, for additional information on the documentation that should be provided.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
