"CONSOLIDATED GUIDANCE ABOUT MATERIALS LICENSES: PROGRAM-SPECIFIC  
GUIDANCE ABOUT LICENSES AUTHORIZING DISTRIBUTION TO GENERAL LICENSEES"  
(STC-16-050)

**Purpose:** To provide the Agreement States with the opportunity to comment on the Office of Nuclear Material Safety and Safeguards draft NUREG-1556, Volume 16, Revision 1, "Consolidated Guidance About Materials Licenses: Program-Specific Guidance About Licenses Authorizing Distribution to General Licensees."

**Background:** The U.S. Nuclear Regulatory Commission (NRC) is revising the licensing guidance in the NUREG-1556 series. The NRC originally published NUREG-1556, Volume 16 in December 2000. The document is intended for use by applicants, licensees and NRC staff, and is also available to the Agreement States.

**Discussion:** NUREG-1556, Volume 16, Revision 1, was updated by a working group made up of NRC and Agreement State representatives, to include safety culture, security of radioactive materials, protection of sensitive information and changes in regulatory policies and practices. The volume was also reviewed by a steering committee made up of NRC management and an Agreement State manager and NRC legal staff. The notice announcing the availability of the draft volume for comment was published in the Federal Register (81 FR 40928) on June 23, 2016:
