The U.S. Nuclear Regulatory Commission (NRC or the staff) determined that the LRA was complete and acceptable for docketing on June 18, 2014.

Since that time, the staff has reviewed the Fermi 2 LRA, performed site audits and inspections, issued requests for additional information (RAIs), reviewed the applicant's responses to the staff's RAIs, developed a safety evaluation report (SER) with open items dated January 28, 2016, and subsequently met with the Advisory Committee on Reactor Safeguards (ACRS) Subcommittee on March 2, 2016. The staff has closed the open item and has developed the enclosed SER to document its findings associated with the safety review of the LRA and supporting documentation for Fermi 2.
