Dear Mr. Slodowitz:

This letter refers to your amendment request in a letter dated April 27, 2016, to change the legal name of your corporation as listed on your license to Area Code 310, Inc., dba CampCo.

The U.S. Nuclear Regulatory Commission (NRC) sent you a letter dated May 24, 2016 (Agencywide Documents Access and Management System [ADAMS] Accession No. ML16144A357), which requested that you provide additional information concerning your application within 30 calendar days of the date of the letter (i.e., by June 23, 2016). Also, an e-mail was sent to you at motti@campco.com informing you that it does not appear that a response from you to our May 24, 2016 letter has been received and that we may discontinue our review of your license amendment request if a complete response is not received by June 28, 2016 (Accession No. ML16180A096).

Because you did not provide the additional information required to complete the requested action within the stated time period, we have voided your application. This action is taken without prejudice to the resubmission of your request; therefore, your application will be re-opened once the NRC receives a complete response to our request for additional information.
